### DEALER TABLES FOR NOVEMBER 21, 2026 ARE **SOLD OUT**

Dealer tables have been selling out the last few shows. We offer our dealers their same tables for the next show. Most dealers take advantage of this option.

We have a Waiting List that moves forward to each show. In other words, if you ask to be added to the Waiting List, you will maintain your position on the list until you ask to be taken off. When a table(s) becomes available, we start contacting those on the List in order. Oftentimes, tables become available at the last minute. If we contact you by phone or text, you must respond or we move on to the next person on the list. You don't lose your spot on the list if you don't respond. You just lose the opportunity. So we must have a good phone number for you. And we need to know to text you, preferred, or to call you. An email address is also good so we can communicate details about upcoming shows to you.

You also need to let us know what you need. If you tell us you need 4 tables and not less than 4 tables, we won't contact you when we only have 2 tables available. But if you have some flexibility, we'll do what we can for you.

We do everything possible to work with our dealers. Our dealers are the backbone of our show and without them, there is NO SHOW. Our Show is very popular with attendees and our dealers alike. We have a few dealers that have been with us from our 1st Show 36 years ago.

We will confirm after each show those dealers on our Waiting List for the next Show.

4. Dealers from the last show have preference for the same tables for the next show.
5. The day after the last show, any available tables for the next are sold to dealers on our Waiting list in the order that they were added to the list.
6. Once a dealer is added to the Waiting List, that dealer stays on the Waiting List from show to show until a table becomes available or they request to be removed from the waiting list.
7. If you wish to be added to the Waiting List, email, text or call us. We need to know the best way to contact you IF a table becomes available - text, email, or phone are the options.

8. **CONTACT US BEFORE PAYING FOR A DEALER TABLE TO CONFIRM AVAILABILITY** by email, text or phone. We pay the credit/debit card processing fee if you pay online. BUT, if **you pay without authorization**, we will deduct the processing fee we pay before refunding your payment. Fees are 5%. The processing fee is not returned to us if your unauthorized order is refunded. **Dealer tables are \$30.00 each for a 30" x 8' standard table.**
